School Description and Mission Statement

Kumeyaay Elementary School is located in the Tierrasanta Norte portion of San Diego. It is surrounded by middle-income, single-family houses, townhouses, and apartments. The school opened in September 1994. It consists of 28 individual permanent and temporary classrooms, a multipurpose room, a library/media center, and an office complex. The school has a large asphalt playground with three playground structures and ample play areas. In addition, the students have a playing field of nearly three acres for use during recess and physical education periods. The school is clean and well kept, creating a pleasant learning environment.

Each year, approximately 10 to 15 percent of our students join the Kumeyaay school community through the district's School Choice program, and approximately 10 percent of students attend Kumeyaay to receive special education instruction. Kumeyaay's student population is very stable, with over 90 percent remaining for the entire school year. Our student population consists of 10 percent English language learners. More than 13 languages other than English are represented by 20 percent of our population.

Kumeyaay Elementary School also provides students with a rigorous, enriched curriculum. This includes enrichment classes in science, music, and fine arts instruction, funded by the Kumeyaay Foundation.

On average, our teachers have 18 years of teaching experience, and three have been certified by the National Board for Professional Teaching Standards.

Our mission is to work together to provide a positive, rich, and challenging instructional program that meets the needs of all students, maintains high standards, and provides a wide range of educational experiences.

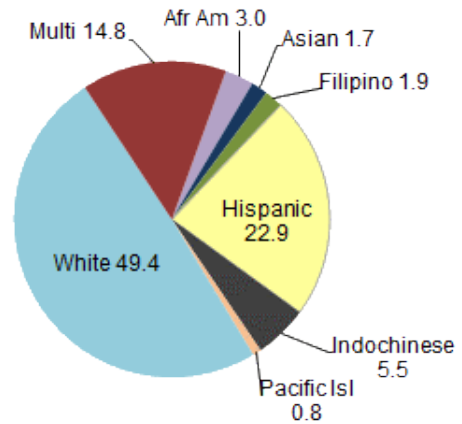

School Facility Conditions and Planned Improvements

Kumeyaay school grounds are beautifully decorated with school murals, art, trees and bushes, and potted plants. Classrooms are neat, organized and inviting to create a comfortable and warm learning environment for students. The school community takes pride in keeping the classrooms and grounds clean and attractive. Our custodial staff works to ensure that the classrooms are clean and ready for instruction each morning, and the district’s mobile maintenance program continues to keep areas painted and well maintained. Kumeyaay has a beautiful joint-use field that is maintained by the San Diego Parks and Recreation Department and is used throughout the year.

The Kumeyaay staff provides supervision on the playground before school starting at 7:30 a.m. Parent volunteers help supervise our morning Running Club. The parking lots have pedestrian walkways and speed bumps to help make traveling through the parking lot a much safer process. San Diego Advocates for Youth (SAY) provide after-school care beginning at 2:10. During the day, the office staff monitors access through the front office, all gates are closed and locked during school hours. Volunteers and visitors are required to sign-in at the office and provide picture identification. Strict student release procedures are in place and followed.

Our school recently received air conditioning units for all classroom spaces. Prior improvements (from Proposition MM) include instructional support space, improved access for the physically disabled, technology and electrical upgrades, and windows and blinds. Currently, our office, library and multipurpose room are in the process of air conditioning installation, and a wall between the kindergarten playground and parking lot is being heightened to ensure safety. Through the district’s i21 program, all classrooms have Promethean interactive whiteboards. Each student in kindergarten through grade 2 has an android device, each student in grades 3 and 4 has a netbook, and each student in grade 5 has an iPad.

Statewide Assessments

CAASPP Assessment Results

The California Assessment of Student Performance and Progress (CAASPP) tests students in English language arts/literacy and mathematics in grades 3 through 8 and grade 11. The CAASPP was piloted in 2013–14 and first administered statewide in 2014–15. The CAASPP consists of the Smarter Balanced Summative Assessments for students in the general education population.

For eligible students, the CAASPP also consists the California Alternate Assessments (CAAs) in ELA and math, which replaced the California Alternate Performance Assessment (CAPA) in 2015 and are aligned with alternate achievement standards linked to the Common Core State Standards for students with significant cognitive disabilities.

CAASPP scores are ranked according to four “performance levels”: Level 1 indicates that the student has not met the standard tested; Level 2 indicates that the student has nearly met the standard; Level 3 indicates that the student has met the standard; Level 4 indicates that the student has exceeded the standard. Students scoring at Levels 3 and 4 have met state standards in that content area.

Note: In the tables that follow the number of students tested includes students who did not receive a valid test score; however, achievement-level percentages have been calculated using only those students who did receive valid scores.

School Safety Plan (2016–17)

Campus safety is the district's top priority. Principals, teachers, support staff, school police services, and community organizations work together to prevent, prepare, and respond to emergency situations. To ensure safety and security, each school has a state-mandated individual emergency response plan that is updated annually and posted on the school's website. School staff members participate in regular emergency-preparedness drills and response training. Substance abuse prevention programs are presented to students regularly. Policies and procedures are in place to address safe entry and exit of students; serious disciplinary problems; discrimination, harassment and bullying; mandated child abuse reporting procedures; and school dress codes.

Adult supervision is provided in the classrooms and outside areas before and after school, during recess and lunch, and during passing time between classes. Under the direction of the principal or site administrator, school staff members implement specific school-building security procedures. In addition, district offices support schools by reviewing and disseminating safety requirements and information, coordinating safety-related services, and providing safety training and assistance.

The Kumeyaay Elementary School safety plan is reviewed yearly and revised as necessary. It outlines the procedures that will be followed by teachers and staff during an emergency. The plan provides for the safe evacuation of our students and an efficient process for reuniting students with parents during a disaster. Monthly safety drills of various types (fire, earthquake, etc.) are held to ensure that students and staff know what to do if an emergency occurs.

Other Information

Professional Development

The district and the Board of Education have set a high priority on professional development, with the goal of providing targeted professional development to build teachers’ leadership capacity and knowledge to support student learning success. The Office of Leadership and Learning collaborates with other departments to provide teachers and administrators with ongoing professional development, including improving teaching and learning related to the Common Core State Standards, educational technology, advanced studies, and leadership

development. Sessions offered at various times throughout the year focus on a wide variety of professional development aimed at strengthening content knowledge to meet the needs of all learners, with an emphasis on targeting the needs of our English language learners, students with disabilities, and other struggling learners.

In addition to district-provided professional development, principals identify a schoolwide focus each year for professional development based on student needs and also to determine areas of individual growth and development. Throughout the year, teachers participate in school-based professional learning communities (PLCs) to encourage best practices and engage in shared problem solving. Teachers are provided with useful data systems that allow them to improve the learning of each student. Staff release for professional development is organized in a variety of ways on a site-by-site basis throughout the year.

Instruction and Curriculum

The San Diego Unified School District Board of Education has formally adopted academic standards and curriculum frameworks approved by the California State Board of Education for all subject areas. District curriculum materials, instructional strategies and supports, professional development, and student assessments are aligned with state standards and focused on ensuring that every student has access to a high-quality, rigorous, and engaging instructional program. A range of support opportunities is available for students needing additional assistance.

Kumeyaay Elementary School provides students with an enriched curriculum, which includes teachers for science, music and fine arts instruction funded by our Kumeyaay Foundation. On average, our teachers have 18 years of teaching experience, and three have been certified by the National Board for Professional Teaching Standards. Our mission is to work together to provide a positive, rich, and challenging instructional program that meets the needs of all students, maintains high standards, and provides a wide range of educational experiences. Instruction is also aligned with the Common Core State Standards, which promote critical thinking, collaborative conversations, fiction and nonfiction text analysis, as well as purposeful, meaningful writing.
