



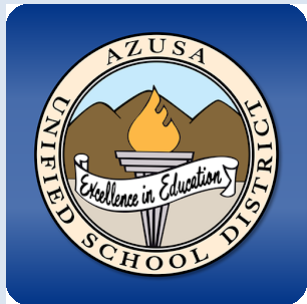

School Description

At Henry Dalton Elementary School, we believe that students, parents and staff members, working together as partners, will ensure that learning and achievement are encouraged and highly valued, and that positive social behavior is expected. We believe that students have the right to learn and teachers have the right to teach. We believe that students and staff members have the right to a safe, civil and productive school environment. We believe that students have the right to expect a calm, friendly environment, with clear behavioral expectations and discipline policies that are consistently and fairly administered. Dalton is a student-centered community focused on promoting educational excellence. The staff works to ensure students have receive quality instruction, diverse opportunities, and develop academically and socially. Dalton programs include a STEM pathway in partnership with Slauson Middle School and Azusa High School; a PBIS program to support positive behavior interventions; Early Bird/ Late Bird Kindergarten program which provides small group instruction for younger students; instrumental music for fifth graders; physical education curriculum; and a Response to Instruction intervention and enrichment model in English Language Arts. There are also partnerships with community programs through companies, universities, and community groups that support families and students. There are frequent events for families, such as Coffee with the Principal, Math and Parent Education Opportunities and informational presentations which are offered to promote learning outside of the regular school day. Technology is also an important component of the program at Dalton. The school has a full computer lab, iPad carts, and Chrome books that are utilized to provide standards based programs in all content areas.

Leadership at Dalton Elementary School is a responsibility shared among district administration, the principal, instructional staff, students, and parents. Laura Clarke serves as principal. Staff members and parents participate in various committees that make decisions regarding the priorities and direction of the educational plan to ensure instructional programs are consistent with students' needs and comply with district goals. These committees include the School Site Council, the Parent Teacher Association (PTA), the English Learners Advisory Committee (ELAC), and Professional Learning Communities.

DataQuest

DataQuest is an online data tool located on the CDE DataQuest Web page at <http://dq.cde.ca.gov/dataquest/> that contains additional information about this school and comparisons of the school to the district and the county. School Facility Conditions and Planned Improvements (Most Recent Year)

Dalton Elementary School provides a safe, clean environment for students, staff, and volunteers. Built in 1951, the school sits on 8.5 acres. Facilities span 337,521 square feet and include a multipurpose room, library, cafeteria, 14 permanent classrooms, and eight portable classrooms, playground, and a computer lab. Facilities information is current as of September 2010. The facility strongly supports teaching and learning through its ample classroom and playground space, and a staff resource room.

A scheduled maintenance program is administered by Azusa Unified School District to ensure that school grounds and facilities remain in excellent repair. A work order process is used when issues arise that require immediate attention. Emergency repairs are given the highest priority; repair requests are completed efficiently and in the order in which they are received.

Opportunities for Parental Involvement (School Year 2017-18)

Parents and community members are very supportive of the educational program at Dalton Elementary School. Parents and the community participate in the Superintendent's Roundtable four times a year, as well as the school's Back-to-School Night, Open House, Teacher/Principal-planned workshops, and "Coffee with the Principal". Parents may also participate on the School Site Council, English Language Acquisition Committee (ELAC), and the Parent Teacher Association (PT A). Parent input is sought to support decisions regarding school programs, the development of the Single Plan for Student Achievement, and input for the district Local Control Accountability Plan. Multiple opportunities for parent education and training are offered, including Grassroots ESL, Families in Schools and subject-area support.

School Safety Plan

The safety of students and staff is Dalton Elementary School's primary concern. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Fire and disaster drills are conducted on a regular basis throughout the school year. Annually, the school participates in a district wide earthquake drill, which includes an entire school evacuation. A storage bin located at the school contains food, water, and other supplies for use during a disaster.

All visitors must sign in at the front office, wear identification tags while on the school grounds and sign out upon departure. The principal, teachers, and support staff supervise the campus during recess, and before and after school, and noon aides supervise during lunch to ensure the safety of all students. Teachers, staff, and administrators are trained and practice lock-down procedures that, in an emergency, can secure the entire campus.

A Comprehensive School Safety Plan was developed by the Safe School Committee in order to comply with Senate Bill 187 of 1997. The plan provides students and staff a means to ensure a safe and orderly learning environment. Key elements of the Comprehensive School Safety Plan include the following: Mission Statement, Discipline Plan, School Climate, Student Drop-off and Pick-up procedures, and Emergency Procedures.

Professional Development provided for Teachers

The district annually holds professional development days where teachers are offered a broad-based variety of professional growth opportunities in curriculum, teaching strategies, and methodologies. The primary areas of focus for professional learning in the last three years have been in the area of supporting teachers as it relates to the adoption of new math, and ELA/ELD curriculum, as well as professional learning on the new mathematics and ELA/ELD Frameworks. Student achievement data continues to be the determining factor in the selection of professional learning topics. Professional learning is developed and facilitated by district staff, Teachers on Special Assignment, and outside consultants and coaches who specialize in English Language Development pedagogy, as well as consultants and coaches who specialize in mathematics pedagogy. Professional learning is structured in job-embedded workshops and professional learning communities which include collaborative lesson planning, lesson study, classroom observations and coaching support, and student work/data analysis. Professional learning for all teachers includes strategies and pedagogy to support all learners access rigorous, grade-level curriculum. All professional learning includes a special emphasis supporting the development of English learners' development of academic language and literacy through instructional strategies that included Sheltered Instruction Observation Protocol (SIOP). In the 2015-2016, 2016-2017, and 2017-2018, there were three district-wide professional learning days each year. Elementary teachers received 2 additional days in 2015-2016. In 2016-2017, each elementary grade level teacher received 2 days of ELA professional learning on new curriculum and instructional support; 6 days of mathematics curricular professional learning and instructional support. In 2017-2018, elementary teachers received 4 additional ELA professional learning days in support of the new ELA/ELD curriculum. Elementary and secondary ELA program 4 and 5 teachers received an additional 4 days of professional learning in support of new curriculum.
